The system enables Regional Rural Banks (RRBs) and Cooperative Banks to submit quarterly claims in a standardized, transparent, and auditable manner, while allowing NABARD to efficiently scrutinize, approve, and monitor claims across Regional and Head Offices.

The system replaces fragmented, manual, and spreadsheet-driven processes with a structured, rule-driven digital workflow. It ensures end-to-end traceability—from data submission and validation to claim computation, certification, and final approval—fully aligned with DAY-NRLM guidelines and NABARD’s governance framework.
